Review of Minutes

February minutes approved as recorded.

Remove (fulfills MNTC...) from CCO's

The (fulfills MNTC areas 2, 5) will remain in the course descriptions so students are aware of the MN Transfer areas each course fulfills. The same course description also populates ISRS, DARS, and CAS which requires the MNTC areas to be listed at the beginning of the course description so students searching for courses meeting MN transfer areas are able to see which areas a course fulfills.

Sports Management Emphasis Proposal

Tabled for future submittal

Recommendation: Faculty will work with Jeff Thomas regarding the investment resources required to develop the new courses in this emphasis area. The emphasis proposal must total 64 credits and all MN transfer areas must be covered. The proposal also Need appropriate documentation from two other higher education institutions to ensure the two years will completely transfer into a four year program.

Deb distributed copies of the Associate of Arts with an emphasis in Sports Management proposal and copies of a UMC sports management program curriculum. The NCTC courses selected were based on the courses required in the similar programs offered at UMC and BSU. Suggestions were made to check on the Psychology of Sport course to determine transferability and fulfillment of the math component. .

Catalog change for Athletic Training

The appropriate paperwork must be submitted to Jeff for discussion then resubmitted to the April meeting for review.

Graduation Honors

NCTC recognizes two separate graduation honors between the two campuses. TRF currently recognizes three levels of academic honors and EGF has two levels. The group determined two levels will be recognized as follows: Highest Honors at 3.75-4.0 and Academic Excellence at 3.5-3.74.

Residency Policy

Dennis indicates the current policy only states students need to take 25% of the total credits at NCTC. Dennis pointed out students are more mobile and the policy should specify when (first 20 credits or final 20 credits) and how many credits (20, 40, 25%) must be taken at NCTC to be awarded a degree. A residency policy will be added to the next agenda.

Liberal Arts AA program

Steve recommended a liberal arts advisory meeting to review the drafts of fall schedule for both campuses to determine synchronizing and to make adjustments in coordinating staffing and efficiencies. The meeting was held at 1 pm on 3/9/05.

Institutional Review Board

EGF students were asked to complete an online survey in regards to their drinking habits. The survey did not indicate what the data will be used for, why it's being collected, or who will review the information. An Institutional Review Board (IRB) should exist if an institution is gathering human subject data. The IRB must ensure all data being gathered is not violating the rights of human subjects. Since one does not exist at NCTC, David Christian has been asked to establish and chair an institutional review board. The group agreed the IRB will consist of faculty from both campuses, an administrator, and an educated community member. By the April meeting, Dave will develop a general guideline draft for gathering human subject data. Suggestions were made to contact Steve Franz or Mike Lopez to determine if any MNSCU policy exists.

BSU Letter

Shari provided a copy of the BUS letter of articulation agreement for the Electronic Technology Marketing AS program. The letter will be submitted to MnSCU with the program redesign.

NCA Update

Kent indicated all documents have been sent to NCA and copies will be placed in the libraries for faculty review. The visit to occur on April 25-26 is based on governance issues. Two NCA members will visit the two campuses for two days.

General Education Policy

A general education policy will be drafted and presented at the April meeting. Suggested content for the policy:

the role of general education within NCTC as an institution.
