Review of November Minutes

The November minutes were reviewed and approved as recorded with the exception of future meeting locations. The committee agreed to meet again via ITV in January; then decide at the January meeting whether the February meeting will remain scheduled via ITV or return to meeting in person.

Online Rubric

The TRF faculty supported the Online Rubric. The EGF faculty had some concerns with the lab science courses due to the fact students could receive credit for lab science courses with excluding any actual lab time. After some discussion, the committee believes the rubric was not developed to cover each component of every course and the lab courses would have some way of providing a student with the lab experience. The EGF faculty also questioned the peer review component; Mike indicated the peer review will be left to the decision of the individual college instead of a consortium approach. Therefore, NCTC must establish a peer review committee and Kathy volunteered to start getting the peer review committee established. The committee approved the online rubric and Kathy will notify the consortium of NCTC's support.

Institutional Learner Outcomes

The question was brought forth as to who was approving the institutional learner outcomes. The belief was that the Assessment Committee was approving them. However, the Assessment Committee indicated the institutional learner outcomes should be approved by AASC. The discussion concluded with the fact that AASC will be reviewing institutional learner outcomes for all courses starting in spring semester. The Assessment Committee will only serve as a consultant in reviewing the institutional learner outcomes and assessment statements. For courses that have already been approved in the new common course outline format, the course subject, number, title, institutional learner outcomes, and institutional learner outcomes assessment statements must be submitted via the Curriculum Modification: Quick Form to AASC for review and approval. Once approved, Karleen will update the CCO. Kathy will ask the Assessment Committee to prepare a guideline on how to complete the institutional learner outcomes and assessment statements.

Academic Record Retention

The committee discussed retaining academic information such as grade books, office notes, syllabus, etc. Mike and Jeff will develop, and then distribute to all faculty a list of academic record information indicating what must be kept and for how long. The document should also be included as part of the new faculty orientation session.

Incomplete CCO's

Kathy indicated General Psychology needs learner outcomes. David will work with TRF on completing the CCO. Kathy requested that administration appoint an individual to review all the common course outlines for consistent formatting.

Finals Week

Mike and Jeff stated a finals week has been established for liberal arts on both campuses starting Fall 2006. Each committee member should research other colleges to gather information as a basis for establishing a policy and report their finding at the next meeting.
