### **Program Web Pages**

Question was raised on how many programs are displayed on the home page. Chad indicated that four to five programs can be displayed on the homepage and will be switched every 3 weeks to a month. The programs in the orange category from the program sustainability report were selected to be rotated first. The website is designed to promote the college as a whole along with program specific marketing. Chad will have a program redesign mockup ready to be presented for faculty review in April. Any website samples should be emailed to Chad to review as he works on the redesign.

## **Advisory Committee Policy**

The committee reviewed the feedback provided by faculty and agreed the language should remain as loose as possible to accommodate the various advisory committee structures. It was suggested the policy section titled Frequency of Meetings be amended to reflect the first few sentences of the same section in the MnScu manual (pgs 17 & 18) which reads: "The frequency of the committee's meetings will be dictated by the work plan. Most committees meet at least twice a year, in the fall and spring. However, if a committee has an especially intense work plan, it may need to meet monthly. In any case, meetings should NEVER be called simply for the sake of holding a meeting. There should always be a reason for a meeting."

### **MnTC Audit Course**

The Academic Affairs and Standards Council at NCTC is advised to either appropriately remove them, revise them according to the Checklist of Evaluation Criteria, or provide a succinct rationale for why the curriculum committee feels they should continue to be included in order to comply with Procedure 3.37.1. Due to the Omnibus Bill, it is even more crucial that institutions follow the Guidelines in determining course placement to prevent transfer difficulties for students.
