#### **Articulation Agreement**

Northland's articulation agreement process has recently been more clearly defined and outlined. The new step-by-step process and proposal form have been posted in Virtual Office under the Articulation Agreements link. The proposal form can be completed by faculty who are seeking an articulation with another institution. A trial run of this process was initiated in January 2010 when the Criminal Justice program sought an articulation agreement with Bemidji State University. Signatures are being acquired by BSU personnel and then this agreement will be complete. Additionally, we are working to make Northland's articulation agreements more visible for current and prospective students. All current articulation agreements have been posted on each program's web page under the Program Facts link, as well as in Virtual Office under the Articulation Agreements link.

### **Needs Assessment Committee**

The committee developed a spreadsheet, containing three weighted tiers, to use when analyzing new program data. Tier I – Student/Community Need – reviews Regional data (job availability, salary, program saturation) and National data (job availability, salary). Tier II – College Need – reviews the credits contributing to common course work and major employer(s) involvement/partnership. Tier III – Current/Potential Student Interest – reviews current and potential student(s) interests. All the data compiled to complete the needs assessment spreadsheet will be submitted to the New Program Development Committee and used as a foundation in preparing/submitting MnSCU's New Program Application.

#### **Policies**

A motion was made, seconded and approved to approve the 2<sup>nd</sup> Reading on the following policies: Career Information, 3050 PSEO, 3060 Syllabus & Common Course Outline, 3070 Academic Progress, 3110 Graduation, 3130 Placement, 3280 Fresh Start.
