Policy

Institutional Research Committee Request

Sherry Lindquist questioned if some of the ISEEK information could be posted on the program web pages. The committee thought it was a good idea. Norma will look into gathering and presenting info to faculty during inservice. Sherry will schedule a meeting with Norma, Karleen, Mary, Gene, Chad, and Jason to develop a process for gathering information being requested.

Noel-Levitz

Jim Hundrieser from Noel-Levitz, who is developing a marketing recruiting strategy for the college, meet with the committee to discuss various issues.

What is the institutional brand?

Quality, a comprehensive community and technical college in the region, small class sizes, personal touch, instructors are masters in field of study.

What is NCTC's image?

College in high school to achieve duel credits through concurrent enrollment, strong technical education background, still working on liberal arts education, partnerships with industry, strong athletic image.

How well does academics work with recruitment, enrollment team to find perspective students?

Prospect lists are sent to faculty and coaches. College use to have pioneer guides to act as faculty mentors for students. Discussion occurred about using client relationship management (CRM) software for recruiting. The CRM retention side has not been implemented yet.

Liberal Arts – refers to the AA degree that transfers into 4 year degrees, also referred to as transfer program. The website needs to be improved on explaining the Liberal Arts degree.

The semester order course sequence per program needs to be more prominent on the website.

Remedial math – 50% pass rate, what happens to those who fail?

The college has worked to improve success rated by pairing developmental Math and English courses together and considered having more advisors to increase personal contact with students. The college has implemented registration access codes so students must meet with an advisor before they can register for courses, ensuring the students are completing the appropriate courses per program.

Retention – at what point do students naturally tend to stop out?

Students tend to finish the technical curriculum but do not complete developmental, general courses required to complete the degree. Within the AA degree, the students complete the courses they want, then transfer to another college, but are short of completing the AA degree by a couple courses or a semester. This might be related to the fact upper level math and science courses are not being offered due to low enrollment sizes at NCTC. Offering those courses via ITV or online could be an alternative.

What role do online courses play?

Students have a larger selection of classes to choose from. All the distance consortium courses are listed together on web. Sometimes hard to determine which campus has seats available. The distance website has been making changes to improve promotion of online courses. It was pointed out that the Minnesota online website has issues with library resources link.

What should we mandate students to participate in?

How to be ready for college, how to study, how to manage time, math—reading--writing skills, personal responsibility.
