AAS Waiver Update

Sometime in June or July, a process for filing AAS degree waivers will be available. The waiver will need to be completed for all AAS degree programs that cannot reduce their credits to meet the 60 / 120 standards. MnSCU has decided that like programs across the state will not have to all be the same number of credits. Next fall, the committee will begin reviewing those waiver forms on NCTC programs.

<u>Common Course Outlines -- Institutional Learner Outcomes</u>

Rocky distributed copies of the common course outlines being generated from ISRS. Discussion occurred regarding the Institutional Learner Outcomes currently associated with each course. The college has since moved toward assessing ILO's at the program level not the course level. Therefore, the committee believes the ILO's should be removed from the common course outlines and the Assessment Committee should determine where the ILO's will be kept. Norma, who serves on the Assessment Committee, will discuss the ILO's at the Assessment meeting next week and report back on where the ILO's will be kept.
