Accounting AAS Transition Plan

EGF -- In the 2nd fall students will follow the new semester sequence with the exception of taking SPCH 1101 instead of ACCT 2200 which was taken year one. The remaining courses are switches between semesters in the second year so students will take them as proposed.

TRF -- In year one ACCT 1108 & ACCT 1124 are semester swaps in the first year so students would have taken the courses in year one not affecting year two continuation.
