AA Degree Changes

Brian Huschle explained to the committee that the Associate of Arts has 12 program learner outcomes that map to the MNTC goal areas 1-10. Then outcomes 11-12 map to the institutional learner outcomes Application of Resources and Personal Development. NCTC is going to change the AA program learner outcomes from the current 12 to the 5 institutional learner outcomes. The assessment results will be more meaningful to liberal arts faculty to improving their course content. This will also simplify the annual process.
