Norm demonstrated new equipment.

Norm added strategic plan to the agenda.

Charlie reported on safety and OSHA type inspections. He reported on two battery incidents.

Norm asked for recommendations for any information regarding new product or vehicle changes that should be incorporated into the program.

Norm reported on NATEF and program assessment.

Kent reported that an assessment and program review process will be in place by summer.

Kelly reported that Ford is not really going away from the WDS, but still is supporting the NGS. Ford has 3 separate ways of training, and that they still have a training center. Discussion was held on new scan tools and diagnostic equipment.
