New Business

- 2017-2018 Program Guidelines are sent out with the new contracts
 - Textbooks are provided by the high schools
 - CHS multiple sections are also multiple sections at NCTC
 - Capacities
 - GPA, no mention of waiver process
- 2017-2018 CHS Fee Structure
 - \$2644 per student? Example: \$1200 student #? \$600 course fee#?
 - PSEO \$10,000-\$11,000 loss to the high school
 - May impact future budgets
 - Hurts smaller schools
 - 50% higher for smaller schools?
 - Re-imbursement formula (minimal?)
 - o IB & AP programs
 - Mentoring credits \$2500 first time, \$1250 after that
 - Under 12 students, we lose
 - General budget makes up the difference
 - "Great community support for the CHS program." –Bill Stock
 - Minnesota State Transfer Pathways
 - About 24 written this year
 - Take the place of articulations
 - Learning outcomes
 - College Algebra same requirements across the system
- 2017-2018 Course Request
 - Schools limiting offerings 30 credit limit per year
 - Higher Learning Commission would require high school to become a satellite
 - Thief River Falls would have Western Civ I each semester to offer Animal Science
 - Rotate courses to offer more variety
 - Credentialed instructors high level
- 2017-2018 Campus Visits for Registration
 - Jackie sent email communicating assessment and registration dates
- 1-Year Out and 4-Year Out Graduate Surveys
 - These surveys were sent out on March 24, 2017
 - They will be analyzed and summarized for the accreditation process
