2. First Report of injury	Becky	No reportable or unreportable injuries to report. Incidents are reported based on the severity of the accident.

Tornado Drill Feedback	Becky/Bob	Bob sent out an email to all emergency evacuation drill 'runners' asking them to join the first 15 minutes of our meeting today to discuss/revise campus maps/drill procedures. Some runners have been replaced because they are not on campus year-round. Unsafe zone areas removed from the map are the NW and South hallways. Safe zone rooms

		added are: 420, 401, 203, 405, 405a & 406. Becky handed out the shared comments
		from our April 12 th drill and left it open for discussion. Bob will make appropriate map and
		procedure changes with Scott in IT Dept. and distribute the newest versions to the
		runners. Runners should close all doors behind them and this request will be added to
		the prerecorded drill announcement. The prerecorded announcement is still not loud
		enough unless conversations in the safe zones are kept to a minimum. In an actual drill,
		must we sit against the west wall with our head between our legs as we have done in the
		past? Becky will be updating the Crisis Management Plan (emergency manual) this
		summer and plans to incorporate all changes that occurred after our last drill.
