MEC Plan Facilitating – Michelle Landsverk:

Community Development Director Christine Anderson introduced Michelle Landsverk. Michelle presented her background in Economic Development along with the meeting facilitation proposal of time allocation and consulting fees. Ms. Landsverk envisions a process in which monthly meetings, two hours per meeting, are held with primary stakeholders for a period of six months. The proposed fees are based on a rate of \$150 per hour for meeting facilitation and \$75 per hour for off-site work, including research, design, analysis and writing at a total cost of \$6,345.

Christine Anderson discussed the possibility of grant funds being available through the Northwest Minnesota Foundation.

Discussion was had and an agreement was made that the use of a facilitator is the best way to go, but consensus of the committee is that Request for Proposals (RFP) should be sent out and give others a chance to make their proposals. Also, that we should take advantage and apply for a grant not only for this initial phase but for future planning and facilitating.

Motion by Carey Castle, being seconded by Wayne Nomeland to move forward with drafting an RFP and bring back to the next meeting in order to distribute to chosen candidates by the Committee.
