Portable Restrooms Update - A proposal was brought forward from ACE Rent-All

3 Portable Restrooms @ \$70 ea. (a month) = \$210 per month

4 months = \$840

3 Portable Restrooms @ \$40 ea. pump (once a week) = \$120

4 weeks a month = \$480

4 Months = \$1920

Currently pump twice a week so times 2 = \$3840

Total cost (rental + pumping) = \$4680

Tree Update - Clinton Castle will meet with City Forester and bring back next month.

Dug Out Update - Dug outs will be moved to the FY19 Budget year.
