Transfer Presentations at Student Success Day     Procedure 3.21.1	Lisa Bottem Lisa Bottem	Jeff Bell and Kate Schmalenberg presented at EGF Lisa Bottem presented at TRF 3 presentation on each campus.  16 occupational credits Procedure 3.21.1, Part 3, Subpart C states, "Transferring occupational/professional course credits. Each system college or university shall accept in transfer as electives up to 16 semester credits of occupational and/or professional courses which are not comparable or not equivalent to specific courses taught at the receiving college or university. A system college or university may accept occupational and/or professional credits beyond 16 credits if the receiving college or university determines they contribute to an educationally coherent program."

			So, while it can be more than 16, since an AA is designed for transfer to a baccalaureate, allowing more than 16 may not contribute "to an educationally coherent program" unless they all apply toward the baccalaureate. In most cases, they wouldn't, and a student is usually better off taking MnTC courses and pre-major requirements for transfer than technical/occupational courses for the 20 credits of electives.
3.	MnTC GPA and treatment of "F" grades	Lisa Bottem	The MnTC GPA is primarily to ensure that when it stands alone, it has an overall GPA of at least 2.0. We wanted to count Ds in MnTC transfer courses since Ds count for "native" students. Since F grades don't count for either "native" or transfer students in the MnTC, you don't have to count them in the MnTC GPA. F grades do count in the cumulative GPA for "native" students.  1 graduate found already. May improve MnTC completion rates.

Reverse Transfer Grant	Rocky	\$500,000 Grant Will Advance Student Success at Minnesota State Colleges and Universities  A formal announcement was made on October 10, 2012 that Minnesota State Colleges and Universities has been awarded the Reverse Transfer grant as discussed at our annual User Conference. It is part of a national initiative to help students who have transferred from community colleges to four-year universities complete their associate degrees, and is called —Credit When It's Due: Recognizing the Value of the Quality Associate Degree. Il  The foundations' initiative is designed to encourage partnerships between community colleges and universities to significantly expand programs that award associate degrees to transfer students when the students complete the requirements for the associate degree while pursuing a bachelor's degree. This approach is commonly known as —reverse transfer. Il The MnSCU project was selected from a nationally competitive grant proposal process. Expect to hear more news about this project in the future, likely through your campus administration.
