Minutes

- **1.** Minutes from previous meeting were approved.
- 2. D2L Follow-up
 - a. Self-Registration Tool: This is on hold as we are waiting for IT to get this set up.
 - b. Support Widget Update: (Tabled until next meeting)
- 3. QM Seal Display: Faculty are unsure as to how to display the QM seal for approved

courses. Recommendation is for this committee to provide guidance on how to do this so there is uniformity. It was decided to create a master QM shell from which the certification widget can be copied. This will include instructions on how to use it. Access to this shell will be through the self-registration tool. Faculty wanting to use the widget will use the custom home page role. Display of the QM seal will be voluntary for those courses that are QM-approved.

- **4. Smart Thinking--Follow-up:** Data over the past two years show usage of this program has dropped dramatically. Part of the problem may be that students think they have to pay for the service when they log-in. Students do not have to pay; MnSCU pays the bill for this service up to a certain cap, after which the College pays the bill. In the past, students from other colleges have logged-in and used some of our hours; we need to determine if this access problem has been fixed. We need to publicize that this service is available and that it is at no cost to students.
- **5. Hybrid Course Guidelines:** This issue is sitting in the "parking lot" on the Shared Governance agenda. Send issue to AASC for approval.
- **6. Software and E-Learning Resources:** Instructors at Northland are not currently using web-based resources that are free to them. They are unaware that these resources are available and there are no "system experts" for these resources. How do instructors know what is available for free (paid for by MnSCU) and how to access these resources? Who is responsible for getting the word out? Need to address the following questions: 1. What resources do we currently have available (inventory)? 2. Do the ones we are paying for make sense? 3. How are faculty using the various software applications?
- **7. Workgroup Item** tabled.
- **8. Virtual meeting tools:** explore at next meeting.
- **9. Strategic Agenda:** Determine other items committee may want to address before the end of the academic year.
