HyFlex Classroom/Zoom Huddle Rooms	Stacey	Update on Learning Network Executive Director, Kim Briske visit & the learning opportunity through Educause ( <a href="Designing Hybrid-Flexible">Designing Hybrid-Flexible</a> (HyFlex) Courses to Support Multimodal Learning Environments). Did our region find a candidate to attend?
		Update: happy to meet with us anytime. Training on eLearning rooms over inservice. We have approval to place at least 1 more room on campus, maybe 2 depending on the cost. The workgroup will ask faculty teaching in the rooms for feedback as we plan new rooms. Codex is \$6,000-\$10,000 per room. We can do the installs ourselves over the summer. Equipment will be placed on order after meeting with faculty for feedback. What other rooms would be good on campus (size/layout)? This process will start towards the end of January. Nobody from Northland signed up for the learning opportunity.
4. Student Choice/Multi-Modal courses	Mary/Angie	Student choice (multi-modal) is a new part of the contract that is being trialed. It is where faculty lets the student decide how to attend/participate in a class. This includes online, on-campus, synchronous, or asynchronous. The faculty sets up the course to operate in each mode and the students chose daily how to participate. This would be considered an online course per HLC. Questioning how many Northland faculty are doing this (accounting is, question if respiratory therapy is, anyone else - Caleb? Sara Dupree). We need to keep tabs on who is using this

		format and obtain feedback from the programs/faculty using it. What is the best way to find this information and obtain feedback?  Faculty should be talking with their Dean about their modality. This will be tabled for now.
