1. Welcome	Kerry @ 1:10pm
Review and Approve     Minutes (November)	Minutes reviewed. Questions clarified. Corrections made and approved.
3. Jan. In-Service Plan	Reviewed Assessment Action Steps for the in-service to prepare for presentation. Kent and Kerry will follow up on this information.
