Minutes

- 1) Minutes were approved from previous meeting, May 8th, 2014.
- 2) Committee Structure, Purpose, & Work plan for this year

APR Committee will:

- Revise the 5-year program review document
- Set calendar for 5-yr program reviews
- Set calendar for annual program assessments
- Update D2L assessment data and information
- Post meeting minutes on website
- Will be directly involved with the review of 5-yr program review reports (change from previous years)
- 3) Program Review: 2014-2015
 - a. We will continue to use the current 5-yr program review format. Changes to program sustainability measures will have some impact on program review reports.
 - b. The following programs are due to complete a 5-yr program review during the 2014-2015 academic year:
 - Accounting, Administrative Assistant, Unmanned Aerial Systems Maintenance Technician, Carpentry, Construction Plumbing, Pharmacy Technology, Welding (TRF), Farm Business Management.
 - c. Draft program review reports are due to academic deans 1 Feb; drafts are due to the APR committee (for feedback) 15 March; final reports are due 4 May 2015. This is the first time that the APR committee will have an opportunity to review draft reports and provide feedback.
- 4) Program Assessment: 2014-2015
 - a. Peggy and Cassie will work together to determine due dates for both annual program assessments and for ILO assessment.
- 5) Sustainability Report Update

Program sustainability reports were revised over the summer to include 3 new measures.

- 6) ILO Assessment: 2014-2015
 - a. Peggy provided an example of a "curriculum map" she obtained from Riverland CC. She suggested that we develop something similar for programs at Northland. Peggy will develop a similar map for her program as a starting point.
 - b. ILOs to be assessed during the 2014-2015 academic year are ILO #2, Critical Thinking; and ILO #3 Information & Applied Technology.
