1. OER Course Identification	Linda	 Linda asked about a better way to identify OER courses. Using a specific section number to identify causes several problems: If students are already registered the section number cannot be changed without first dropping the students and then re-registering them after the number is changed. For on-campus classes, the Registrar's office staff need to be involved in dropping, re-registering and then notifying the students of the reason for change. For distance classes, the Distance office needs to be contacted of the necessary section number change and then they have to drop the students, change the section number and then re-register the students. Section numbers are also used by the HR Service Center staff to help identify distance, on-campus, COI, ITV, etc. Mike and Brian will bring up at Distance meetings next week. Adding a Media Code to identify OER courses would be a better solution.
