Now has a link directly to career wise web page. Shows career needed, wages, jobs and employment outlook. This means we won't have to update this info every year. This box has been added to all career program pages. Some programs career outlook page doesn't tell the entire story (work hours – annual salary based on 32, or 40 hours, etc.).
